### **About Plantlife**

- Founded in 1989, Plantlife now has 20,000 members and many more supporters.
- Plantlife is the only UK membership charity dedicated to conserving wild plants and fungi in their natural habitats and helping people to enjoy and learn about them.
- Plantlife works across all key plant ecosystems and habitats focussing on specific habitats and species depending on need. Its current priorities in the UK are grasslands and temperate forests due to their acute vulnerability and on at-risk species recovery.
- Plantlife owns 24 nature reserves covering nearly 4,500 acres across England, Scotland, Wales and the Isle of Man. It carries out conservation and outreach work on its own land and in partnership with many others. Plantlife advises landowners and publishes best practice guidance. It carries out research and gathers data to inform government policy.
- Working with the Global Partnership for Plant Conservation, Plantlife was instrumental in the creation of the Global Strategy for Plant Conservation and the initiation of Important Plant Areas across the world planning their conservation with government and community groups.

# About the role

Fungi have been missing from the full conservation picture over the years, but this is slowly shifting as more people and organisations realise fungi are incredibly important to ecosystems and humans in multiple ways that we are only just beginning to understand.

Further work and investment is required to understand the beneficial impacts of fungi, how they will be affected in different ecosystems by climate change, and how conservation efforts could help secure their future. Plantlife is keen to learn more about this Kingdom, to increase and share knowledge and information. We need to understand fungi in so many more ways, including impacts on biodiversity protection and restoration, their role in the delivery of better conservation outcomes, and the role they might play in climate change adaptation and mitigation.

We have secured funding to develop and deliver an initial 3-year programme for fungi, with sixmonthly milestones to ensure we work at pace towards Plantlife's strategic ambition of fungi being globally recognised, monitored, and conserved for their fundamental role in solving the nature and climate emergencies.

In this new permanent role the postholder will work to strengthen and extend our existing network with relevant stakeholders. Together with organisations working in mycological conservation they will collaboratively identify shared priorities and current conservation activities to develop a new strategy for conservation of the UK's fungi. They will also facilitate collaborative research projects and support ongoing fungi activities within Plantlife's existing programmes.

The post will sit within our science team, which leads on conservation research and evidence, as part of the Conservation Directorate. As well as immediate team members, the postholder will work closely with Plantlife's specialist advisors, the policy team, and other colleagues across England, Scotland and Wales.

#### **Overall Purpose of the Role**

To develop a strategic and collaborative approach to Plantlife's fungal conservation and science work, working with stakeholders to develop and deliver a programme for fungi to ensure they are recognised, monitored and conserved in the UK.

Including through:

- Being a representative for Plantlife on conservation of fungi
- Identifying shared priorities and current levels of fungal conservation activities with stakeholders
- Networking to facilitate connections between scientists and practitioners
- Developing collaborative research projects to improve understanding of the role of fungi within ecosystems, and their value
- Providing insight to ensure fungi are considered in our conservation, learning and advocacy programmes

#### **Main Responsibilities**

- Work with Plantlife colleagues and external stakeholders who are currently active in mycological conservation to develop a strategic plan for conservation of fungi.
- Provide mycological expertise and support to colleagues within Plantlife for ongoing fungal activities within Plantlife's conservation programmes.
- Create online resources for conservation of fungi in the UK.
- Work with colleagues to embed the needs of fungi into policy and legislation across the UK.
- Identify research and evidence gaps and develop collaborative research projects.
- Work to enhance Plantlife's existing citizen science activities related to fungi, and develop new activities.
- Manage budgets and expenditure as necessary.
