Primarily focused on policy in England and with a focus on Westminster, the programme will also connect with Rethink Nature activity and advocacy within all nations of the UK.

Rethink Nature is a group of leading species-focused nature conservation organisations working together to combine our extensive knowledge and experience to catalyse the action that species need across the four nations of the UK.

Rethink Nature is governed by a board of CEOs supported by an active Conservation Leads group.

Working together since 2013, Rethink Nature initiated the Back from the Brink (England), Species on the Edge (Scotland) and Natur Am Byth (Wales) species recovery partnership programmes, and the Westminster Species Champion Project.

Our people

Plantlife is governed by a board of 12 trustees and has almost 100 staff located across the UK. Most of our team work remotely and we have offices in Salisbury, Wiltshire and Retford, Nottinghamshire. We have a small hub of hybrid or office-based staff based out of these offices and there is always space for visiting colleagues who are close enough to occasionally benefit from an office space when they wish. We support a team of around 1,500 volunteers who work in the field, at events and in its offices.

Our work is only achievable through working inclusively with the public, partners, land managers and local communities. By working inclusively, we will provide equality of opportunity to connect with nature, reducing barriers to access and participation.

This all starts with the people that work for us and we are looking for great individuals, whatever the role you are interested in, to enable us to get more people involved with nature. We want to ensure that everyone who works for us feels truly valued and included so that they feel able to share their diverse and unique perspectives and reach their full potential.

People of colour and disabled people are currently underrepresented across the environment, climate, sustainability, and conservation sector. 


About the role

Overall purpose of the role

To increase governmental and sectoral support for species recovery by:

- implementing a Rethink Nature policy and advocacy strategy and work programme for species recovery,
- enabling the Rethink Nature partnership to increase its advocacy effectiveness for species recovery, including via support for MP Species Champions focused primarily in England and through Westminster.



Main responsibilities

- Deliver the Rethink Nature Advocacy Strategy and work programme, working collaboratively with Rethink Nature conservation and policy staff.
- Measure outcomes to demonstrate progress and determine success of the Advocacy Strategy.
- Coordinate support from the Rethink Nature partnership to enable joined-up action including responses to policy consultations and advocacy opportunities
- Gather evidence (case studies, proposed solutions, position papers) from the Rethink Nature partnership and wider sector to demonstrate thought leadership in species conservation.
- Provide coordination support for the Westminster MP Species Champions projects, working with Rethink Nature and other partners
- Develop a communication approach to ensure Rethink Nature speaks as one voice in its advocacy for species conservation.
- Act as a spokesperson for the Rethink Nature partnership on species recovery policy.
- Facilitate Rethink Nature's engagement and actively establish relationships with key decision makers and stakeholders, including Rethink Nature partnerships in other UK nations.
- Contribute to the overall success of Rethink Nature and support a positive culture through effective collaboration, communications and leadership.

Other duties and responsibilities

- Observe Plantlife working policies at all times, including those on Health and Safety and Equal Opportunities.
- Undertake, from time to time, other duties that may be required of you to support the effectiveness of Plantlife overall.

We are looking for a driven, proactive and enthusiastic policy advocate who is passionate about working to solve the nature crisis and specifically recognises the imperative to focus on species recovery. You must be naturally collaborative, an excellent communicator, well organised and adaptable to changing priorities.

Your experience should demonstrate a relevant understanding of environmental policy, stakeholder engagement and influencing.

Essential skill requirements

- A passion for nature recovery.
- Experience of nature conservation policy, advocacy and strategy.
- Relevant understanding of environment and biodiversity policy and legislation, and their implications for conservation practice.
- Proven experience of operating successfully in a senior policy, advocacy or public affairs role.
- A natural collaborator, able to facilitate, effectively negotiate and influence others to make decisions and take action.
- Understanding of the devolved approach to UK environmental policy.
- Excellent communication skills and attention to detail (verbal, written and presentational), including an ability to speak confidently to a variety of audiences.
- Strong time management, prioritisation and organisational skills.
- Able to work independently.

- Experience of working with eNGOs.
- Direct experience of species protection and/or biodiversity policy and legislation.
- Experience of campaign strategy and delivery.
- Experience of working in multiple political systems.
